CUT POLICY

ADULT CODE OF CONDUCT (Please initial here _____)

Each adult, whether parent, coach, or volunteer, must sign the Adult Code of Conduct to be involved in the program or to have their child participate.

EQUIPMENT RETURN (Please initial here _____)

Football players will be issued football equipment during the month of August. The issued equipment must be returned in good condition at the end of the season. If the equipment is not returned in acceptable condition, I understand and agree that I will be charged \$250.00 to replace the equipment.

DISCLOSURE RE: WAIVER OR LAWSUIT (Please initial here _____)

Each person participating in the Newport-Mesa Jr. All American Football Program, coaches, parents, and players must sign a written Contract. Among the provisions of this Contract are the following:

The Contract requires all persons involved in the program agree to give up any legal right that they would have to file a lawsuit against Newport-Mesa Jr. All American Football (“NMJAAF”) or its parent organization, Orange County Jr. All American Football (“OCJAAF”) in which it is alleged that NMJAAF and/or OCJAAF or either of its officers, directors, or coaches has failed to follow the NMJAAF or OCJAAF rules.

In the past, parents have filed lawsuits in which complaints were filed due to the manner in which either OCJAAF or NMJAAF has enforced a rule(s), has been unfair, or handled a dispute improperly. Historically, the courts have ruled that due to OCJAAF and NMJAAF organizations operating as a “volunteer-only” organization, the courts determined these lawsuits to be without merit and should be handled as a “private dispute”. Additionally, the courts take the view that the remedy of a parent, player, or coach who feels that they have been the subject of an unfair or wrong decision by OCJAAF and/or NMJAAF is to resign from the organization. In order to discourage the filing of needless lawsuits, which ultimately are likely to be turned down by the courts, a provision has been included in the Contract which states that any participant in the program give up any right to file any such lawsuits. Should any participant disagree with this policy and pursue a lawsuit, the participant will be liable for any attorney’s fees that are incurred by OCJAAF and NMJAAF in defense of a lawsuit.

FEE POLICY (Please initial here _____)

Registration fees are due and payable **in full** on registration day. Should the full registration fee not be received prior to the first scheduled practice of the season, the player is subject to removal from the team roster. NMJAAF accepts VISA and MasterCard as well as checks and cash payments. Any returned checks will be subject to a \$50.00 returned check fee and would require payment to be made via credit card/money order/cash only.

REFUND POLICY (Please initial here _____)

If a player chooses not to play or for any reason, or is unable to play, there will be **NO REFUND**. The only consideration for a refund would be: if a player is cut from the team prior to team certification. A refund equivalent to 50% of the registration fee will be considered, if the player does not make weight at team certification, or if a player sustains an injury during a practice or scrimmage prior to the first league game. In the event of an injury, a written request for refund must be submitted to the Board for approval. The written statement should have details of the injury and be immediately forwarded to the Chapter President, Debbie Branca, by facsimile (949) 722-1145. Moreover, even if a player is entitled to a refund that refund will not be given until full equipment return is made to the Chapter Equipment Manager.
